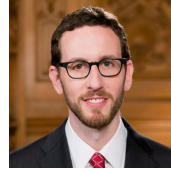
The Honorable Scott Wiener

Senator Wiener, fresh off passing his monumental legislation, SB35, will discuss the new package of housing bills headed for Governor Brown's desk.

SB35 will streamline the approval process in cities that have fallen behind state housing goals, by easing some local development restrictions.

Plans for the new \$1 Billion Measure H Fund to Fight Homelessness

As Director of the LA County Office of Homeless Initiative, Phil oversees the new funding from Measure H, passed by LA County voters in March 2017. Measure H is projected to raise \$355 million annually for next 10 years. Phil will discuss the adopted three-year \$1 billion plan to fund rental subsidies, services to support those placed in permanent housing, outreach and strengthening and expansion of the shelter system.

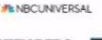
